Wheels India net profit at Rs. 12.58 cr, revenue up 11% to Rs. 1,131 cr

Chennai Jan 31: Wheels India Ltd., has registered a net profit of Rs. 12.58 crores for the Q3 ended 31st December 2023 as compared to Rs. 15.36 crores registered in the corresponding quarter of the previous year. Revenues for Q3 ended 31st December 2023 went up 11.1% to Rs. 1,131 crores as compared to Rs. 1,018 crores for the Q3 ended 31st December 2022. The revenue growth in Q3 was driven by a strong recovery in exports. The company registered export revenues

of Rs. 307 crores in Q3 ended 31st December 2023 as compared to Rs. 205 crores in the corresponding quarter of the previous year. Commenting on the results, Srivats Ram, MD, Wheels India Ltd., said, "The profits in Q3 were impacted by low demand in the tractor and mining wheel segments and by the floods that affected our Padi plant in the first week of December. There was no power for a week at our plant in Padi, and we were not able to run it to full capacity in that

to grow our exports for the 4th consecutive quarter. When compared to Q3 of last year, growth came in the machining of castings for windmills and in hydraulic cylinders, apart from aluminium wheels." On the near-term outlook, Srivats said "While the global economy is likely to slow down next year, we are hopeful of continuing to grow our exports. On the domestic front, we expect the Indian economy to show reasonable growth post elections."

Madras HC orders restriction of non-Hindus

Madurai, Jan 31: Justice S. Srinathy of the Madurai Bench of the Madras High Court on Tuesday directed the State government, the Hindu Religious and Charitable Endowments Department and temple authorities to install boards at the entrance of temples, near the Kodimaram, and at all prominent places on such premises, indicating that non-Hindus were not allowed beyond

the Kodimaram of the temples. If a non-Hindu seeks to visit a particular deity in a temple, the authorities shall obtain an undertaking from the individual that he/she has faith in the deity, and would follow the customs and practices of Hinduism and of the temple. On obtaining such an undertaking, the non-Hindu may be allowed to visit the temple, the judge said.

Whenever a non-Hindu is allowed entry based on such an undertaking, the same shall be recorded in a register maintained by the temple. The authorities shall strictly follow the agamas, customs and practices of the temple, she said, and directed the authorities not to allow non-Hindus who do not believe in the religion beyond the kodimaram.
